2.1.1 Keyboard

All functions in the SOFDZ are included in the popup menus of the application.

Some areas of SOFDZ do not support keyboard navigation properly, and users cannot navigate / focus on them by keyboard.

The following areas in SOFDZ do not support showing the popup menus by using keyboard:

1. All docking windows in Optimize SQL module.
2. All grids heading in Optimize SQL module.

2.1.2 No Keyboard Trap

If keyboard focus can be moved to a component of the page using a keyboard interface, then focus can be moved away from that component using only a keyboard interface, and, if it requires more than unmodified arrow or tab keys or other standard exit methods, the user is advised of the method for moving focus away.

Partially Supports SOFDZ 5.6.2 supports large fonts of the Microsoft Windows settings in all title bars, docking windows bars, toolbars, and in some dialogs. Users can reads rest of the unsupported large font areas by using the Magnifier of the Microsoft Windows accessibility features
